Subject: Discontinuation of offline submission of transaction level data commencing 01.04.2013 and submission of only ONLINE

Hitherto Non-Life Insurers have been submitting transaction level data of the following lines of business through offline as well as online mode.

- > Health
- > Motor
- > Other Lines Of Business (Fire, Marine & Engineering)

As the quality of the online submission has stabilized now, they are requested to STOP offline submission ie., CD submission/e-mail commencing from 2013-14 submission. They shall kindly ensure that their online submission contains all the data items properly filled-in, in order to cater to the demand from insurers to produce qualitative analytics. We reiterate that in the case of **Motor** and **Other Lines Of Business (OLOB)**, the advice is to right away stop sending Offline data. Owing to special issues involved in health data submission, the following clarification is given w.r.t only Health portfolio.

HEALTH:

Till now, there are two categories of health data submission viz., 1) Commercial data 2) Govt health data(like RSBY). Non-Life Insurers have been submitting **commercial** data through offline as well as online mode. Offline commercial data submission shall stop henceforth.

Non-Life Insurers have been submitting **Govt health transaction level data(like RSBY)** through offline only. Commencing from 2013-14, they shall submit the same (**each scheme separately**) also through online mode and **STOP** off-line submission thereof. **The specifics of the upload procedure of Govt. transaction level data will be circulated shortly.**

In order to give more clarity, Non-Life Insurers are hereby requested to submit only online upload of commercial non-life health transaction level data other than Govt health transaction level data(like RSBY). Online upload of Govt health transaction level data can be commenced after specific instructions are issued therefor.
