# **Item No. 1:** Selection of Vendor for the Supply and installation of Video Conferencing System.

The Committee examined the proposal and observed that the EOIs had been received from the below indicated vendors:

- 5. Tulip Telecom Ltd.

It was noted that the tenders received from these vendors were opened by a Committee consisting of the following officials, on 3<sup>rd</sup> August 2012.

Subsequently, all the vendors were shortlisted for the Technical and Commercial bidding and an EMD of Rs.2 lakhs was obtained.

The tenders were opened by the tender committee in the presence of the bidders on 27<sup>th</sup> June 2012. The compiled information is as follows:

The committee observed that Tulip Telecom Ltd has quoted for Rs. 22, 53,892/which is the lowest. The vendor has complied with the terms and conditions. However, the price quoted by them (Rs.3.57 lacs) in respect of 55" LCD it was found to be higher than the other quotations for similar product. The lowest price quoted in respect of 55" HD LCD TV- 2 Nos. for SONY model is Rs. 2,99,250/-. The committee concluded that L1 meets the specifications and solutions meet the Tender specifications and clarifications issued by IRDA.

Tulip Telecom Ltd will supply video conferencing equipment with High definition quality in order to facilitate connectivity with eight (8) different locations simultaneously. The facility will support ISDN leased line and telephone network. The vendor will deploy its personnel four (4) times in a month as per the requirement of the video conferencing sessions of IRDA. The vendor will also provide a three years comprehensive onsite warranty.

The Committee approved the proposal, to place the order with Tulip Telecom Ltd in line with the recommendations of the tender committee with an overall cap of Rs.22,53,892/- Inclusive of all Taxes as may be applicable, subject, to the tender committee negotiating the prices of accessories quoted by Tulip Telecom Ltd to the lowest of all the quotations. The committee also recommended that the selected vendor should provide the brand names for the accessories being supplied.
