Administration Department submitted the agenda items as follows:

Agenda: Integrated Video Conferencing (VC) facility in the Board Room

IRDAI has two small Conference Rooms with Video Conferencing Facility, which can accommodate around 10-15 participants each. The Authority has a Meeting Room with a capacity of 35-40 participants. However, this meeting room is not equipped with VC facility. After the Covid, it has become a norm to conduct/convene meetings in Virtual mode, through Video Conferencing or in Hybrid mode. Thus, there is a need to upgrade the infrastructure facilities of IRDAI to meet the current requirements

- 2) As the current facilities do not support VC facility with higher number of participants, it is becoming a challenge to conduct meetings seamlessly in a hybrid mode. In the absence of VC facilitation in office, these meetings have to be either arranged outside or we need to immediately set up a VC system in office itself which is a more viable, and reasonable option. There is, thus, an emergent need to set up/establish In-house Video Conferencing Facility to accommodate larger audience.
- 3) Additionally, the installed projectors in the Board Room have poor visibility due to low resolution and there are repeated complaints on the effectiveness of the meetings due to the said visibility

constraints by the participants. There is, thus, an urgent need to set up Video Walls/Screens in the place of projectors to enable a better viewing experience for seamless meetings.

4) With the above background, it was approved for procurement of the following through GeM, as per details given in the following paras:
