Agenda 1: Finalisation of AMC of Hardware for IRDAI Hyderabad Office

With regard to agenda related to finalisation of AMC of Hardware IRDAI Hyderabad office, the committee observed the following:

1. The following bidders have not satisfied their eligibility criteria in spite of providing ample time to the bidders for submission of proof and hence their bids have not been considered.-

Agenda 2: CRs for Agency Licensing Portal

Regarding Agency Portal requirements CGM (IT) explained the following:

1. User department proposed the change requirements to Agency Portal and the requirements were discussed and finalized by the user department.

- 2. Efforts less than 100 man hours have not been charged by M/s ESDS, as per the agreement.
- 3. The man month rate of Rs. 44200/- is as per the agreement.
- 4. Detailed effort estimation sheets submitted by M/s ESDS are attached and the same is in order.

After deliberations, the committee recommends to implement the Change Requests as per the proposal submitted by the Vendor M/s ESDS, to the total cost of Rs.3,73,690/-.

Agenda 3: Procurement of Laptops and software for Inspection Department

With regard to agenda related to procurement of Laptops and software for Inspection Department, the committee observed the following:

- 1. M/S Microbase Computers has quoted for Dell Laptop with 14" inch screen, which has not satisfied the specification asked in RFP. In RFP screen size of the Laptop asked is "15 inch or more". As M/S Microbase Computers has not submitted the quote as per the RFP, its bid is disqualified.
- 2. As per RFP, total 10 No's MS Office Home & Business 2016 software Licenses has been asked to quote, where as M/S Youdan Marketing has submitted bid for 4 Nos only. For calculation purpose the unit price of MS Office Home & Business 2016 software has been taken and arrived the total amount for 10 No's Licenses.
- 3. As per RFP, in view of having total 3 years warranty on Laptop, it has been asked to quote for 2 years extended warranty apart from Standard Warranty. In response to that, all the bidders have quoted for total 3 years warranty except, M/S Digitech Pheripherals, who has quoted for 3 years plus additional 2 years, total 5 years warranty. In commercial compilation, the price quoted for 3 years warranty has been considered for uniformity.
