Defined Term	Meaning
<b>Age:</b>	age of the Life Insured at last birthday.
<b>Annual Premium:</b>	means an amount of Premium payable in a year as chosen by the Policyholder including the loadings for modal premium but excluding the underwriting extra premiums, as specified in the Schedule which is utilised for the purpose of calculating the Benefits payable under the Policy.
<b>Annualised Premium:</b>	means an amount of Premium payable in a year as chosen by the Policyholder, excluding the underwriting extra premiums and loadings for modal premiums, if any, as specified in the Schedule which is utilised for the purpose of calculating the Benefits payable under the Policy.
<b>Appointee:</b>	means the person named in the Schedule who will accept and hold in trust all amounts payable under the Policy on behalf of the Nominee, if the Nominee is less than Age 18 on the date of payment.
<b>Death Benefit:</b>	means the benefit which is payable on death of the Life Insured.
<b>Grace Period:</b>	means the number of days from the due date of premium specified in the Schedule for the payment of premium without any penalty/late fee and during which the Policy is considered to be in-force with the risk cover.
<b>IRDAI / Authority:</b>	means the Insurance Regulatory and Development Authority of India established under the Insurance Regulatory and Development Authority Act, 1999.
<b>Insurance Act:</b>	means The Insurance Laws (Amendment) Act, 2015 and as amended from time to time.
<b>Life Insured:</b>	means the person named in the Schedule on whose life this Policy is effected.
<b>Large Premium Benefit:</b>	means an additional benefit payable on account of the payment of excess premium over and above the minimum annualized premium.
<b>Maturity Date:</b>	means the date specified in the Schedule on which the Policy Term expires.
<b>Maturity Benefit:</b>	means the benefit payable at the end of Policy Term.
<b>Nominee:</b>	means the person specified by You, registered with Us and who is authorised to receive the Benefits under the Policy.
<b>Policy:</b>	means the contract of insurance as evidenced by this Policy document, the Proposal Form, the Schedule/(s) and any other information/document/(s) provided to Us in respect of the Proposal Form and any endorsement issued by Us.
<b>Policyholder:</b>	means You, the owner of the Policy as named in the Schedule.
<b>Policy Term:</b>	means the term of the Policy chosen by You and specified in the Schedule and is the time period between the Policy Commencement Date and the Maturity Date.
<b>Policy Anniversary:</b>	means the date corresponding with the Policy Commencement Date specified in the Schedule in every calendar year.
<b>Policy Year:</b>	means a period of twelve (12) months commencing from the Policy Commencement Date and every Policy Anniversary thereafter.
<b>Policy Commencement Date:</b>	the date as shown in the Policy Schedule from which the Policy Anniversaries, Policy Term, Policy Years, and Premium Due Dates are determined.
<b>Policy Schedule</b>	means the Schedule and any endorsements attached to and forming part of this Policy and if any updated Schedule is issued, then, the Schedule latest in time.
<b>Premium</b>	means an amount payable by You by the due dates and in the manner specified in the Schedule, to secure the benefits under this Policy, excluding service tax or any other taxes, cesses or levies, if any (present and/or future)
<b>Premium Paying Term:</b>	means the term as specified in the Policy Schedule, during which the Premiums are payable by You to Us under this Policy.
<b>Proposal Form:</b>	means the form filled in and completed by You for the purpose of obtaining insurance cover under this Policy.
<b>Risk Commencement Date:</b>	means the date on which Your rights, benefits and risk cover begin, as shown in the Policy Schedule.
<b>Reduced Paid Up</b>	means the continuance of this Policy with reduced paid up benefits, as specified under Section 3 (e) of Part C.
<b>Revival / Reinstatement:</b>	means the restoration of this Policy (discontinued due to the non-payment of premiums by You), upon receipt of all due premiums and other charges, if any, as per the terms and conditions of this Policy and upon We being satisfied of the continued insurability of the Life Insured basis the information,

	documents and reports furnished by You, in accordance with the Board approved Underwriting Guidelines.
<b>Revival Period:</b>	means a period of two consecutive years from the due date of the first unpaid premium.
<b>Surrender:</b>	means the complete withdrawal or termination of the Policy by the Policyholder.
<b>Surrender Value:</b>	means an amount payable on surrender of this Policy as per Section 1 of Part D of this Policy.
<b>Underwriting Extra</b>	means an additional amount charged by Us as premium, as per Our Board approved underwriting policy, which is determined on the basis of disclosures made by You in the Proposal Form or on the basis of any other information received by Us including through medical examinations of the Life Insured in relation to this Policy.
<b>We/Our/Us/Company:</b>	means Edelweiss Tokio Life Insurance Company Limited.
<b>You/ Your / Policyholder:</b>	means the Policyholder as named in the Policy Schedule.

### **BENEFITS**

#### 1. **Death Benefit:**

'Sum Assured on Death' during the Policy Term will be equal to or higher of:

- 10 times of Annualized Premium;  
or
- Sum Assured on Maturity;  
or
- 105% of total Premiums paid (excluding any underwriting extras, rider premiums, service tax and cess, if any) till the date of death;  
or
- Any absolute amount assured to be paid on death which is equal to 10 times of Annual Premium for Premium Paying Term of 7 years, 11 times of Annual Premium for Premium Paying Term of 10 years and 13 times of Annual Premium for Premium Paying Term of 12 years.

'Assured Additions' - The assured addition will accrue at the beginning of every year starting from the 13<sup>th</sup> Policy Year till death or maturity, whichever is earlier. The assured addition for each year is equal to Annualized premium x assured addition rates. Please refer to **Annexure A** for Assured Additions Rates.

	<b>When Payable</b>	<b>Amount Payable</b>
(i)	If the Life Insured dies before the Maturity Date, We will pay:	a. Sum Assured on Death; <b>Plus</b> b. Accrued Assured Additions, if any, accrued till the date of death
(ii)	On death during the first 23 months from the Policy Commencement Date where the Entry Age of the Life Insured is less than 5 years, We will pay:	105% of total premiums paid (excluding any underwriting extras, rider premiums, service tax and cess, if any) till the date of death.
(iii)	On death after the completion of 23 months from the Policy Commencement Date where the Entry Age of the Life Insured is less than 5 years, We will pay:	Death Benefit as mentioned in Clause (i) above.
Note: (1) Any amount payable as Death Benefit shall be reduced by the following: <ul style="list-style-type: none"><li>• the outstanding loan amount, accumulated interest and due premiums with interest, if any;</li><li>• the unpaid premiums in the Policy Year when death occurs, if the Life Insured has chosen Premium frequency other than Annual.</li></ul>		
(2) For the Life Insured's age below 5 years at the time of proposal, the risk cover will commence one month prior to the second Policy Anniversary.		

#### 2. **Maturity Benefit:**

'Sum Assured on Maturity' is equal to Annualised Premium X Premium Payment Term (as mentioned in the Policy Schedule) + Large Premium Benefit, if any.

3. **Payment Of Premium & Discontinuance Of Premium Payment:**

<b>a)</b>	<b>Payment of Premium:</b>
	You shall pay Premium for the Premium Paying Term. The amount of Premium payable, the frequency at which it must be paid and the due dates for each instalment of Premium are stated in the Policy Schedule.
<b>b)</b>	<b>Grace Period:</b>
	If We do not receive the Premium in full by the premium due date, then:  (i) We will allow a Grace Period of 30 days during which You must pay the Premium due in full.  (ii) The benefits under the Policy and the Rider if any will continue to apply, during the Grace Period subject to the deduction of the due premiums.
<b>c)</b>	<b>(i) Premium Discontinuance (for Premium Paying Term of 7 years):</b>
	If the default in payment of Premium occurs before the second Policy Year and if the Premium due under the Policy is not received in full within the Grace Period, the Policy shall immediately and automatically lapse and no benefits (Surrender Value or Reduced Paid-Up Value) shall be payable by Us under the Policy. You will be given two years from the date of first unpaid premium to revive Your Policy. On premium discontinuance after first two Policy Years' full premiums are received, the Policy will acquire Paid-Up Value.
	<b>(ii) Premium Discontinuance (for Premium Paying Term of 10 and 12 years):</b>
	If the default in payment of Premium occurs during the first 3 Policy Years and if the Premium due under the Policy is not received in full within the Grace Period, the Policy shall immediately and automatically lapse and no benefits (surrender value or reduced Paid-Up Value) shall be payable by Us under the Policy. You will be given two years from the date of first unpaid premium to revive Your Policy. On premium discontinuance after first three Policy Years' full premiums are received, the Policy will acquire Paid-Up Value.
<b>d)</b>	<b>Revival norms:</b>
	The Policy (and any applicable Riders) may be revived within two years from the due date of the first unpaid Premium by giving Us a written notice to revive the Policy and payment of all overdue premiums with an interest, as may be declared by Company from time to time, for every completed month from the date of first unpaid premium.  The revival will be effected on receipt of the proof of continued insurability and subject to medical examination, if required (cost to be borne by the policyholder). On interpretation of the results if the Life is accepted by the Underwriter, only then the Policy would be allowed to revive. The effective date of revival is when these requirements are met and approved by Us.  The Policyholder may choose to discontinue the rider premium even though he is paying the premium pertaining to the underlying base product to which the rider is attached. In such a case of rider premium discontinuance, the rider is not allowed to be revived in future. Revival would be as per Board approved underwriting guidelines. However, in case the entire policy premium (the base product and the rider) has been discontinued and the Policyholder wants to revive the same then he/she would be allowed to revive within two years from the date of the first unpaid premium as mentioned above.
<b>e)</b>	<b>Reduced Paid-Up:</b>
	Under the Reduced Paid-Up Status, Your Policy will continue with the reduced Paid-Up Benefits, and on death or maturity, which is earlier, after the Policy has acquired a Paid-Up status, the following reduced Paid-Up Benefits would become payable:  (i) On Death, the Paid-Up benefits will be equal to: a) Higher of Paid-Up Sum Assured on Maturity or 105% of total premiums paid (excluding any underwriting extras, rider premiums, service tax and cess, if any) till date of death <b>Plus</b> b) Accrued Assured Additions on Paid-Up.

- (ii) On Maturity, the paid-up benefits will be equal to (Sum Assured on Maturity plus Total Assured Additions) x (No. of Premiums paid/No. of Premiums payable).

Where,

- a) Paid-up Sum Assured on Maturity = Sum Assured on Maturity x (Number of premiums paid/ Number of premiums payable)
- b) Assured Additions on Paid-Up = Annualized premium X Assured Additions Rate x (No. of Premiums paid/No. of Premiums payable).

- (ii) If the Life Insured (whether sane or not) commits suicide within one year from the date of Revival/Reinstatement of the Policy, then the Policy shall be void and We will pay the higher of "80% of the Premium received till the date of death" OR "Surrender Value available as on the date of death".

If the complaint/grievance has still not been resolved You may any time approach the office of the Insurance Ombudsman established by the Central Government of India as per Rule 12 (1) and Rule 13 of the Redressal of Public Grievances Rules, 1998 ('RPG Rules').

### **Powers of Insurance Ombudsman under Rule 12(1) of RPG Rules:-**

The Ombudsman may receive and consider the following complaints:

- (a) Complaints under Rule 13 (as mentioned below);
- (b) Any partial or total repudiation of claims by an insurer;
- (c) Any dispute in regard to premium paid or payable in terms of the policy;
- (d) Any dispute on the legal construction of the policies in so far as such disputes relate to claims;
- (e) Delay in settlement of claims;
- (f) Non-issue of any insurance document to customers after receipt of premium.

### **Manner in which complaint is to be made Rule 13 of RPG Rules:-**

1. Any person who has a grievance against the Insurer/Company/Us, may himself or through his legal heirs make a complaint in writing to the Ombudsman within whose jurisdiction the branch or office of the Company, complaint against is located.
2. The complaint shall be in writing duly signed by the complainant or through his legal heirs and shall state clearly the name and address of the complainant, the name of the branch or office of the insurer against which the complaint is made, the fact giving rise to complaint supported by documents, if any, relied on by the complainant, the nature and extent of the loss caused to the complainant and the relief sought from the Ombudsman.
3. No complaint to the Ombudsman shall lie unless:
  - (a) the complainant had before making a complaint to the Ombudsman, made a written representation to the Company/insurer named in the complaint and either insurer had rejected the complaint or the complainant had not received any reply within a period of one month after the insurer concerned received his representation or the complainant is not satisfied with the reply given to him by the insurer.
  - (b) the complaint is made not later than one year after the insurer had rejected the representation or sent his final reply on the representation of the complainant; and

(c) the complaint is not on the same subject matter for which any proceedings before any court or Consumer Forum or arbitrator is pending or were so earlier.

**Section 39 - Nomination by policyholder**

Nomination of a life insurance Policy is as below in accordance with Section 39 of the Insurance Laws (Amendment) Act, 2015 as amended from time to time. The extant provisions in this regard are as follows:

01. The policyholder of a life insurance on his own life may nominate a person or persons to whom money secured by the policy shall be paid in the event of his death.
02. Where the nominee is a minor, the policyholder may appoint any person to receive the money secured by the policy in the event of policyholder's death during the minority of the nominee. The manner of appointment to be laid down by the insurer.
03. Nomination can be made at any time before the maturity of the policy.
04. Nomination may be incorporated in the text of the policy itself or may be endorsed on the policy communicated to the insurer and can be registered by the insurer in the records relating to the policy.
05. Nomination can be cancelled or changed at any time before policy matures, by an endorsement or a further endorsement or a will as the case may be.
06. A notice in writing of Change or Cancellation of nomination must be delivered to the insurer for the insurer to be liable to such nominee. Otherwise, insurer will not be liable if a bonafide payment is made to the person named in the text of the policy or in the registered records of the insurer.
07. Fee to be paid to the insurer for registering change or cancellation of a nomination can be specified by the Authority through Regulations.
08. On receipt of notice with fee, the insurer should grant a written acknowledgement to the policyholder of having registered a nomination or cancellation or change thereof.
09. A transfer or assignment made in accordance with Section 38 shall automatically cancel the nomination except in case of assignment to the insurer or other transferee or assignee for purpose of loan or against security or its reassignment after repayment. In such case, the nomination will not get cancelled to the extent of insurer's or transferee's or assignee's interest in the policy. The nomination will get revived on repayment of the loan.
10. The right of any creditor to be paid out of the proceeds of any policy of life insurance shall not be affected by the nomination.
11. In case of nomination by policyholder whose life is insured, if the nominees die before the policyholder, the proceeds are payable to policyholder or his heirs or legal representatives or holder of succession certificate.
12. In case nominee(s) survive the person whose life is insured, the amount secured by the policy shall be paid to such survivor(s).
13. Where the policyholder whose life is insured nominates his:
  - a. parents or
  - b. spouse or
  - c. children or
  - d. spouse and children
  - e. or any of them- the nominees are beneficially entitled to the amount payable by the insurer to the policyholder unless it is proved that policyholder could not have conferred such beneficial title on the nominee having regard to the nature of his title.
14. If nominee(s) die after the policyholder but before his share of the amount secured under the policy is paid, the share of the expired nominee(s) shall be payable to the heirs or legal representative of the nominee or holder of succession certificate of such nominee(s).
15. The provisions of sub-section 7 and 8 (13 and 14 above) shall apply to all policies maturing for payment on the commencement of The Insurance Laws (Amendment) Act, 2015.
16. If policyholder dies after maturity but the proceeds and benefit of the policy has not been paid to him because of his death, his nominee(s) shall be entitled to the proceeds and benefit of the policy.
17. The provisions of this Section 39 are not applicable to any life insurance policy to which Section 6 of Married Women's Property Act, 1874 ('MWP Act') applies or has at any time applied except where, a nomination is made in favour of spouse or children or spouse and children whether or not on the face of the policy it is mentioned that it is made under Section 39. Where nomination is intended to be made to spouse or children or spouse and children under Section 6 of MWP Act, it should be specifically mentioned on the policy. In such a case only, the provisions of Section 39 will not apply.

**Section 38 - Assignment and Transfer of Insurance Policies**

Assignment or Transfer of a Policy should be in accordance with Section 38 of the Insurance Laws (Amendment) Act, 2015 as amended from time to time. The extant provisions in this regard are as follows:

01. This policy may be transferred/assigned, wholly or in part, with or without consideration.
02. An Assignment may be effected in a policy by an endorsement upon the policy itself or by a separate instrument under notice to the Insurer.
03. The instrument of assignment should indicate the fact of transfer or assignment and the reasons for the assignment or transfer, antecedents of the assignee and terms on which assignment is made.
04. The assignment must be signed by the transferor or assignor or duly authorized agent and attested by at least one witness.
05. The transfer of assignment shall not be operative as against an insurer until a notice in writing of the transfer or assignment and either the said endorsement or instrument itself or copy thereof certified to be correct by both transferor and transferee or their duly authorised agents have been delivered to the insurer.
06. Fee to be paid for assignment or transfer can be specified by the Authority through Regulations.
07. On receipt of notice with fee, the insurer should Grant a written acknowledgement of receipt of notice. Such notice shall be conclusive evidence against the insurer of duly receiving the notice.
08. If the insurer maintains one or more places of business, such notices shall be delivered only at the place where the policy is being serviced.
09. The insurer may accept or decline to act upon any transfer or assignment or endorsement, if it has sufficient reasons to believe that it is
  - a. not bonafide or
  - b. not in the interest of the policyholder or
  - c. not in public interest or
  - d. is for the purpose of trading of the insurance policy.
10. Before refusing to act upon endorsement, the Insurer should record the reasons in writing and communicate the same in writing to Policyholder within 30 days from the date of policyholder giving a notice of transfer or assignment.
11. In case of refusal to act upon the endorsement by the Insurer, any person aggrieved by the refusal may prefer a claim to IRDAI within 30 days of receipt of the refusal letter from the Insurer.
12. The priority of claims of persons interested in an insurance policy would depend on the date on which the notices of assignment or transfer is delivered to the insurer; where there are more than one instruments of transfer or assignment, the priority will depend on dates of delivery of such notices. Any dispute in this regard as to priority should be referred to Authority.
13. Every assignment or transfer shall be deemed to be absolute assignment or transfer and the assignee or transferee shall be deemed to be absolute assignee or transferee, except
  - a. where assignment or transfer is subject to terms and conditions of transfer or assignment; OR
  - b. where the transfer or assignment is made upon condition that
    - i. the proceeds under the policy shall become payable to policyholder or nominee(s) in the event of assignee or transferee dying before the insured OR
    - ii. the insured surviving the term of the policySuch conditional assignee will not be entitled to obtain a loan on policy or surrender the policy. This provision will prevail notwithstanding any law or custom having force of law which is contrary to the above position.
14. In other cases, the insurer shall, subject to terms and conditions of assignment, recognize the transferee or assignee named in the notice as the absolute transferee or assignee and such person
  - a. shall be subject to all liabilities and equities to which the transferor or assignor was subject to at the date of transfer or assignment and
  - b. may institute any proceedings in relation to the policy
  - c. obtain loan under the policy or surrender the policy without obtaining the consent of the transferor or assignor or making him a party to the proceedings
15. Any rights and remedies of an assignee or transferee of a life insurance policy under an assignment or transfer effected before commencement of the Insurance Laws (Amendment) Ordinance, 2014 shall not be affected by this section.

**Section 45 – Policy shall not be called in question on the ground of mis-statement after three years**

Provisions regarding policy not being called into question in terms of Section 45 of the Insurance Laws (Amendment) Act, 2015 as amended from time to time are as follows:

01. No Policy of Life Insurance shall be called in question **on any ground whatsoever** after expiry of 3 years from

- a. the date of issuance of policy; or
- b. the date of commencement of risk; or
- c. the date of revival of policy; or
- d. the date of rider to the policy

- whichever is later.

02. On the ground of fraud, a policy of Life Insurance may be called in question within 3 years from

- a. the date of issuance of policy or
- b. the date of commencement of risk or
- c. the date of revival of policy or
- d. the date of rider to the policy

- whichever is later.

For this, the insurer should communicate in writing to the insured or legal representative or nominee or assignees of insured, as applicable, mentioning the ground and materials on which such decision is based.

03. Fraud means any of the following acts committed by insured or by his agent, with the intent to deceive the insurer or to induce the insurer to issue a life insurance policy:

- a. The suggestion, as a fact of that which is not true and which the insured does not believe to be true;
- b. The active concealment of a fact by the insured having knowledge or belief of the fact;
- c. Any other act fitted to deceive; and
- d. Any such act or omission as the law specifically declares to be fraudulent.

04. Mere silence is not fraud unless, depending on circumstances of the case, it is the duty of the insured or his agent keeping silence to speak or silence is in itself equivalent to speak.

05. No Insurer shall repudiate a life insurance Policy on the ground of Fraud, if the Insured / beneficiary can prove that the misstatement was true to the best of his knowledge and there was no deliberate intention to suppress the fact or that such mis-statement of or suppression of material fact are within the knowledge of the insurer. Onus of disproving is upon the policyholder, if alive, or beneficiaries.

06. Life insurance Policy can be called in question within 3 years on the ground that any statement of or suppression of a fact material to expectancy of life of the insured was incorrectly made in the proposal or other document basis which policy was issued or revived or rider issued. For this, the insurer should communicate in writing to the insured or legal representative or nominee or assignees of insured, as applicable, mentioning the ground and materials on which decision to repudiate the policy of life insurance is based.

07. In case repudiation is on ground of mis-statement and not on fraud, the premium collected on policy till the date of repudiation shall be paid to the insured or legal representative or nominee or assignees of insured, within a period of 90 days from the date of repudiation.

08. Fact shall not be considered material unless it has a direct bearing on the risk undertaken by the insurer. The onus is on insurer to show that if the insurer had been aware of the said fact, no life insurance policy would have been issued to the insured.

09. The insurer can call for proof of age at any time if he is entitled to do so and no policy shall be deemed to be called in question merely because the terms of the policy are adjusted on subsequent proof of age of life insured. So, this Section will not be applicable for questioning age or adjustment based on proof of age submitted subsequently.
