Annualized Premium	The amount payable by you towards this Plan, in a Plan Year.
	The Sum Assured payable under this Plan will be determined by us on the basis of the Annualized Premium.
Appointee	The person nominated/ chosen by you to receive the proceeds or the benefits under this Plan, if the Age of the Nominee is less than 18 (Eighteen) years.
Automatic Trigger Based Investment Option	Automatic Trigger Based Investment Option means the investment option specified in Section 16.2 and chosen by you in the Proposal Form.
Business Day	Any usual working day of our corporate office in Mumbai on which our office is open for any transaction with our customers.
Discontinuance Charge	A charge levied by us on the Discontinuance of Plan i.e. on complete withdrawal from the Plan.
	The Discontinuance Charge will be appropriated by cancellation of Units from the Unit Account at the time of such complete withdrawal.
	The Discontinuance Charge levied by us under this Plan is specified in Annexure D.
Discontinuance of Plan	Surrender or termination or cancellation of this Plan before the Maturity Date or on non-payment of the due Regular Premiums or Limited Premiums, as the case maybe, before the expiry of the notice period, as specified in Section 9.1.
Discontinued Plan Funds	A segregated/ separate Fund maintained by us out of the fund value of all our discontinued plans in accordance with the Regulations
Grace Period	An additional period of 30 (Thirty) days from the due date for payment of Premium for yearly and 6 (Six) monthly Premium payment mode and 15 (Fifteen) days for monthly Premium payment mode.
Fund	Each specific and separate investment fund established, offered, operated and managed by us in accordance with Section 16 for this Plan.
Fund Management Charge	A charge levied by us a percentage of the Fund Value. It is appropriated by adjusting the NAV and is charged at the time of computation of NAV on the Valuation Date.

Policy Administration Charge	A charge which represents the expenses other than those covered by Premium Allocation Charges and Fund Management Charges.
	Policy Administration Charge is levied at the beginning of the each Plan month from the Fund Value by cancellation of the Units for an equivalent amount.
	The Policy Administration Charge levied by us under this Plan is specified in Annexure D.
Premium	An amount that you pay us either as Single Premium or as Regular Premiums or Limited Premiums for securing the benefits under this Plan.
	The Premium payable by you is specified in the Plan Schedule.
Premium Allocation Charge	It is a percentage of the Premium appropriated towards charges from the Premiums received by us.
	The Premium Allocation Charge levied by us under this Plan is specified in Annexure D.
Premium Paying Term	The time period during which you need to pay your Regular Premiums or Limited Premiums, as the case maybe, to us for securing the benefits under this Plan.
	Your Premium Paying Term is specified in the Plan Schedule.
Proceeds of the Discontinued Plan	It is the Fund Value as on the date of Discontinuance of Plan.
Proposal Form	The proposal form completed and submitted by you based on which we have issued this Plan to you.

Sum Assured	An amount payable on the Life Assured's death during the Plan Term provided we have received the due Premiums and this Plan is in force.
	The Sum Assured payable under this Plan is as follows:
	For Regular Premium and Limited Premium mode
	If the Age of the Life Assured on the Plan Commencement Date is less than 45 (Forty Five) years, then, an amount, which will be the highest of the following:
	i. 10 (Ten) times the Annualized Premium; or
	ii. 0.5 * Plan Term * Annualized Premium.
	If the Age of the Life Assured on the Plan Commencement Date is equal to or more than 45 (Forty Five) years, then, an amount, which will be the highest of the following:
	i. 7 (Seven) times the Annualized Premium; or
	ii. 0.25 * Plan Term * Annualized Premium.
	For Single Premium mode
	i. If the Age of the Life Assured on the Plan Commencement Date is less than 45 (Forty Five) years, then 125% (One Hundred Twenty Five percent) of the Single Premium paid by you to us; or

- Words of one gender will include the other gender and the singular will include the plural and vice versa, unless the context otherwise requires
- Days mean calendar days, unless stated otherwise
- Reference to any statutory enactment includes any subsequent amendment to that statutory enactment
- Please refer to the Plan Schedule for understanding the benefits payable, Premium payable, due dates for payment of Premium and other terms as mentioned in the below terms and conditions of this Plan

# 2. Executive Summary

#### Key Features about this Plan

- IndiaFirst Money Balance Plan is a nonparticipating, unit linked endowment insurance plan which is available on Regular Premium, Limited Premium and Single Premium basis
- The highest of the Sum Assured or the Fund Value is paid on the Life Assured's death during the Plan Term

- The Fund Value, as on the Maturity Date, is paid to the Life Assured on the Maturity Date
- Automatic Trigger Based Investment Option

You can optimize your investments if you have opted for the Automatic Trigger Based Investment Option under this Plan. We help you build your savings systematically while securing the earnings on your investment through an automatic transfer in relatively safe funds that give consistent returns

Before the Plan Commencement Date, you have the option to choose the Automatic Trigger Based Investment Option provided you have agreed to invest in the Equity1 Fund. If you have opted for the Automatic Trigger Based Investment Option. then, we will review your Unit Account at the end of each Business Day to see if the simple absolute return on your investments in the Equity1 Fund (after deducting the Premium Allocation Charge, Policy Administration Charge, Mortality Charge and switching charge) is 10% (Ten percent) or more at the end of that Business Day. If the simple absolute return is 10% (Ten percent) or more on such Business Day, then, an amount equal to the appreciation will be transferred to the Debt1 Fund (i.e. if the value of the Units in the Equity1 Fund is 10% (Ten percent) or more of the net amount invested in Equity1 Fund, then, an amount equivalent to the appreciation will be transferred to the Debt1 Fund.)

Let us assume that the Fund value is now INR 29,760 which is higher than 10% (Ten percent) of the net amount in invested in the Equity1 Fund. In such a case, INR 3,360 (INR 29,760 – INR 26,400) will be transferred to the Debt1 Fund under the automatic trigger based transfer option.

Thus, you will be able to enjoy and secure up to a certain extent the upswings in fund value due to market linked performance of the Equity1 Fund. The gains from the Equity1 Fund will be automatically transferred to a relatively safe fund i.e. to the Debt1 Fund.

- You can make the most out of your investments by switching from one Fund to another
- You can access your money in case of any financial emergency through Partial Withdrawals
- Enjoy tax benefits on the Premium you invest under Section 80C of the Income Tax Act and on the death and maturity benefits under Section 10(10D) of the Income Tax Act

# 3. Benefits Payable under this Plan

#### 3.1. Death Benefit

Upon the Life Assured's death on or after the Risk Commencement Date but before the Maturity Date, the highest of the following benefits are payable:

- · Sum Assured: or
- Fund Value, as on the date of receipt of intimation of death of the Life Assured by us

The minimum death benefit payable will be at least 105% (One Hundred Five percent) of the total Premiums received by us till the date of death of the Life Assured.

Subject to the terms and conditions of this Plan, the aforesaid death benefit will become payable to the Nominee/ Appointee/ legal heir (as applicable) as specified in Section 5.1 provided this Plan is in force and we have received the due Premiums.

If the death of the Life Assured occurs before the Life Assured has attained the Age of 60 (Sixty) years and provided this Plan is in force, then, the Sum Assured for the purposes of payment of death benefit will be reduced by an amount equivalent to the Partial Withdrawals, if any, made by you during the 24 (Twenty Four) months immediately preceding the death of the Life Assured.

If the death of the Life Assured occurs when the Life Assured has attained the Age of 60 (Sixty) years or after the Life Assured has attained the Age of 60 (Sixty) years and provided this Plan is in force, then, the Sum Assured for the purposes of payment of death benefit will be reduced by an amount equivalent to the Partial Withdrawals, if any, made by you during the 24 (Twenty Four) months prior to the Life Assured attaining the Age of 60 (Sixty) years and all subsequent Partial Withdrawals made after the Life Assured attains the Age of 60 (Sixty) years.

### 3.2. Maturity Benefit

The Fund Value, as on the Maturity Date, is payable provided the Life Assured is alive on the Maturity Date.

Subject to the terms and conditions of this Plan, the aforesaid maturity benefit will become payable to the Life Assured provided this Plan is in force and we have received the due Premiums.

You may choose to receive the aforesaid maturity benefit in periodic equal installments under the Settlement Option, as specified in Section 15 by giving a written notice to us atleast 3 (Three) months before the Maturity Date. In case of the Life Assured's death during the Settlement Period, only the balance Fund Value (as on the date of receipt of intimation of the Life Assured' death) will be payable to the Nominee and the Settlement Option will terminate immediately.

#### 3.3. Rider Benefit

Under this Plan, no riders are offered by us.

# 4. In the Event of the Policyholder's Death

- 4.1. If the Life Assured is a minor, then, on the Policyholder's death (provided the Policyholder and the Life Assured are different persons) any surviving parent or legal guardian who has an insurable interest may become the policyholder by submitting a written request to us. On receipt of such written request and information as may be required by us, we will issue a written endorsement. Under this Plan, there is no benefit payable on the Policyholder's death during the Plan Term.
- 4.2. If the Life Assured is a minor, then, on the Policyholder's death (provided the Policyholder and the Life Assured are different persons) if any surviving parent or legal guardian who has an insurable interest may not want to become the policyholder then plan will terminate and surrender value if any will be paid to the Policyholder's legal heirs or legal representatives or to a person as directed by a court of competent jurisdiction as per terms and conditions of the Plan.
- **4.3.** If there is no surviving parent or legal guardian and the Life Assured is a minor, then:

- if the Policyholder's death occurs after the expiry of the Lock-in-period, the Plan will terminate after paying the Fund Value to the Policyholder's legal heirs or legal representatives or to a person as directed by a court of competent jurisdiction; or
- if the Policyholder's death occurs before the expiry of the Lock-in-period, the Fund Value will be transferred to the Discontinued Plan Funds after deducting the applicable Discontinuance Charges. Upon the expiry of the Lock-in-period, the Proceeds of the Discontinued Plan will become payable to the Policyholder's legal heirs or legal representatives or to a person as directed by a court of competent jurisdiction and the Plan will terminate

# 5. Payment of Benefits

- 5.1. The death benefit under this Plan will be payable to the Nominee/ the Appointee/ legal heirs/ assignee/ person as directed by a court of competent jurisdiction.
- **5.2.** The maturity benefit payable under this Plan will be paid to the Life Assured.
- 5.3. All benefits including the Sum Assured and other sums under this Plan will only be paid in India and in Indian Rupees.
- **5.4.** Payment of the death benefit or the maturity benefit will constitute a good, valid and sufficient discharge of our liability under this Plan.

# 6. Making a Claim

### 6.1. Steps involved in making a claim

In order to process a claim under this Plan, we will need a written intimation about the claim, upon the death of the Life Assured during the Plan Term. This is the first step towards processing your claim. The written intimation should also be accompanied with all the required documents as mentioned below:

- Proof of Age of the Life Assured, if the Age of the Life Assured has not been admitted by us
- Claimant's statement and claim intimation report
- Death certificate issued by the local health and

- medical authority (only in case of death of the Life Assured)
- Copies of First Information Report, post mortem report, duly attested by the police (only in case of unnatural death of the Life Assured including accidental death etc.)
- Hospitalization documents including discharge summary, all investigation reports (only in case the Life Assured was treated for any illness related to the cause of death)
- Original Plan document
- A copy of photo-identity proof of the claimant and documents establishing the rights of claimant (e.g. driving license, PAN card, passport, Voter ID card etc.)
- Any other document or information that we may need for validating and processing the claim

# 7. Premium Payment

- 7.1. Under this Plan, you have an option to pay the due Premiums to us as Regular Premium or Limited Premium or as Single Premium.
- 7.2. Regular Premiums and Limited Premiums can be paid to us either by monthly/ 6 (Six) monthly/ yearly payment mode, as selected by you in the Proposal Form. The Premiums should be paid on or before the due dates to avoid Discontinuance of Plan. benefit will constitute a good, valid and sufficient discharge of our liability under this Plan.

# 8. Missing Your Premium

- 8.1. You are provided a Grace Period in case you miss paying your Premium on the due dates. All your Plan benefits continue during the Grace Period.
- **8.2.** In case of the Life Assured's death during the Grace Period, we will pay the death benefit and the Plan will terminate.
- 8.3. Grace Period is only available for the Plan where Regular Premiums or Limited Premiums, as the case may be, are payable under this Plan

# 9. Discontinuance of the Plan before the Lock-in-period

- 9.1. If you have not paid the due Regular Premiums or Limited Premiums, as the case maybe, by the end of the Grace Period, we will send you a notice within a period of 15 (Fifteen) days from the expiry of the Grace Period. You may then exercise one of the following options within a period of 30 (Thirty) days from the date of receipt of the said notice.
- revive the Plan within the Revival Period; or
- complete withdrawal from the Plan without any risk cover
  - The Fund Value will continue to be a part of the Funds chosen by you till the time you exercise one of the above options or till the expiry of the notice period of 30 (Thirty) days, whichever is earlier. During this notice period, the Plan will continue to be in force in accordance with the terms and conditions of this Plan and we will deduct all the applicable charges.
- 9.2. If you send us a written notice within 30 (Thirty) days from the date of receipt of notice, as specified in Section 9.1 to revive this Plan, then, this Plan can be revived within the Revival Period at our discretion in accordance with our board approved underwriting policy if you have:
- paid all the due unpaid Regular Premium or Limited Premium, as the case maybe; and
- submitted a declaration of good health and the Life Assured may have to undergo medical examination, if required. You will have to bear the cost of medical examinations, if any
- 9.3. During the Lock-in- period, if you exercise the option of reviving this Plan and we have not received the due unpaid Regular Premiums or Limited Premiums, as the case maybe, till the expiry of the notice period of 30 (Thirty) days, then, the Fund Value of this Plan will be transferred to the Discontinued Plan Funds. The Fund Value will continue to remain in the Discontinued Plan Fund and no risk cover will be provided till the Plan is revived during the Revival Period or till the expiry of the Lock-in-period, whichever is later.

- 9.4. If you exercise the option of reviving this Plan and we have not received the due unpaid Regular Premiums or Limited Premiums, as the case maybe, till the expiry of the notice period of 30 (Thirty) days, then, the Fund Value of this Plan will be transferred to the Discontinued Plan Funds. The Fund Value will continue to remain in the Discontinued Plan Fund irrespective of the expiry of the Lock-in-period (i.e. if the Revival Period is not completed at the expiry of the Lock-in-period) and no risk cover will be provided till the Plan is revived during the Revival Period or till the expiry of the Revival Period. whichever is earlier.
- 9.5. Upon revival of the Plan, the risk cover will be restored along with the investments made in the Funds as chosen by you out of the Discontinued Plan Fund, less the applicable charges. All the due and unpaid premiums without charging any interest plus Premium Allocation Charge and Policy Administration Charge will be collected and the balance amount will be invested in the chosen Fund to purchase the Units at the NAV as on the date of revival. The Discontinuance Charge, if any, already deducted will be added back to the Discontinued Plan Fund and the amount will be used to purchase the Units at the NAV as on the date of revival.
- 9.6. If you exercise the option of complete withdrawal from this Plan without any risk cover or if you fail to exercise any of the options specified in Section 9.1 within the notice period of 30 (Thirty) days, then, the Fund Value will be transferred to the Discontinued Plan Funds. In such a case, the Proceeds of the Discontinued Plan will become payable to you at the end of the Lock-in-period and this Plan will terminate.

# 10. Discontinuance of the Plan after the Lock-in-period

10.1. If you do not pay the due Regular Premiums or Limited Premiums, as the case maybe, after the Lock-in Period, then, we will send you a notice within a period of 15 (Fifteen) days from the expiry of the Grace Period to exercise one of the following options within a period of 30 (Thirty) days from the date of receipt of the said notice:

- revive the Plan within the Revival Period; or
- complete withdrawal from the Plan without any risk cover; or
- convert the Plan to a Paid-Up Plan

The Fund Value will continue to be a part of the Funds chosen by you till the time you exercise one of the above options or till the expiry of the notice period of 30 (Thirty) days, whichever is earlier. During this period, the Plan will continue to be in force in accordance with the terms and conditions of this Plan and we will deduct all the applicable charges.

- 10.2. 10.2. If you send us a written notice within 30 (Thirty) days from the date of receipt of notice, as specified in Section 10.1 to revive this Plan, then, this Plan can be revived within the Revival Period at our discretion in accordance with our board approved underwriting policy if you have:
- paid all the due unpaid Regular Premium or Limited Premium, as the case maybe; and
- submitted a declaration of good health and the Life Assured may have to undergo medical examination, if required. You will have to bear the cost of medical examinations, if any
- 10.3. Upon revival of the Plan, the risk cover will be restored along with the investments made in the Funds as chosen by you, less the applicable charges. All the due and unpaid premiums without charging any interest plus Premium Allocation Charge and Policy Administration Charge will be collected and the balance amount will be invested in the chosen Fund to purchase the Units at the NAV as on the dat of revival.
- 10.4. If you exercise the option of complete withdrawal from the Plan, then, this Plan will be terminated after paying the Fund Value and the Plan cannot be revived thereafter.
- 10.5. If you do not exercise any option within the notice period of 30 (Thirty) days, then, it will be considered that you have opted for the option of complete withdrawal from the Plan. In such a case, the Plan will terminate after paying the Fund Value and the Plan cannot be revived thereafter.

- 10.6. If you have opted to convert the Plan into a Paid-Up Plan, then, the Sum Assured will be reduced to the extent of Paid-Up Sum Assured. The Fund Value will be a part of Funds chosen by you and all charges will continue to get deducted as described under this Plan. On the Life Assured's death under a Paid-Up Plan, the Paid-Up Sum Assured or Fund Value, whichever is higher will become payable to the person as specified in Section 5.1 and this Plan will terminate. On survival of the Life Assured till the Maturity Date, the Fund Value will become payable and this Plan will terminate.
- 10.7. In case of Regular Premium/ Limited Premium, after 5 (Five) Plan Years, if the Fund Value is not sufficient to deduct all the applicable charges, then, the Plan will be foreclosed. In case of Paid-Up Plan or non-payment of future due Premiums after 5 (Five) Plan Years, if the Fund Value falls below 110% (One Hundred Ten percent) of Annualized Premium, then, the Plan will be foreclosed and the Fund Value will become payable.

# 11. Units, Unit Account and Net Asset Value

- 11.1. We will open a Unit Account on the Plan Commencement Date. We will apply the Premiums received for allocation of the Units at the prevailing NAV to the Unit Account in the Funds chosen by you and in the allocation proportion as opted by you and specified in the Plan Schedule after deducting the applicable charges under this Plan.
- 11.2. The NAV of the Funds will be calculated on each Valuation Date as follows -

NAV =

(Market value of investment held by the Fund + value of current assets - value of current liabilities and provisions, if any)

Number of Units existing on the Valuation Date (before creation/ redemption of the Units)

- 11.3. We reserve the right to value the NAV less frequently than every day in the following circumstances:
- When one or more stock exchanges which provide a basis for valuation for a substantial

- portion of the assets of the Fund are closed otherwise than for ordinary holidays
- When, as a result of political, economic, monetary or any circumstances out of the control of the Company, the disposal of the assets of the Fund are not reasonable or would not reasonably be practicable without being detrimental to the interests of the remaining policyholders
- In the case of natural calamities, strikes, war, civil unrest, riots and bandhs
- In the event of any natural disaster or any situation beyond our control that affects our normal functioning
- If so directed by the Regulatory Authority
- 11.4. In respect of the Premiums received by us through a local cheque or a demand draft payable at par at the place where the Premium is received before 3:00 pm on a Business Day, the closing NAV of the day on which the Premium is received will be applicable. In respect of the Premiums received by us through a local cheque or demand draft payable at par at the place where the Premium is payable, after 3:00 pm on a Business Day, then, the closing NAV of the next Business Day will be applicable.
- 11.5. In respect of Premiums received by us through outstation cheques, demand drafts at the place where the Premium is received, standing instructions on credit card/ debit card, then, the closing NAV of the day on which such cheques or demand drafts or instruments is realized shall be applicable.
- 11.6. In respect of valid applications received by the Company for surrender/ Discontinuance of the Plan, Partial Withdrawal, Fund switch, maturity, death claims payable under the Plan etc. by 3:00 pm on a day, then the closing NAV of the same day shall be applicable. In respect of valid applications received by the Company for surrender/ Discontinuance of the Plan, Partial Withdrawal, maturity, death claims payable under the Plan etc. after 3:00 pm on a day, then the closing NAV of the next Business Day will be applicable.
- 11.7. If the date of receipt of a valid application/instrument is not a Business Day, then, the

- closing NAV of the next Business Day will be applicable.
- 11.8. We may change the cut-off time subject to prior approval of the Regulatory Authority. In such case, we will intimate you the changed cut-off time.
- 11.9. The payment of the benefits under the Plan will be made by cancellation of the required number of Units from the respective Funds. If more than one Fund has been invested in, the cancellation of Units will be effected to the extent possible in the same proportion as the total value of the Units held in each Fund, unless specified otherwise by you and accepted by us in writing.

# 12. Charges

- **12.1.** Under this Plan, we will levy the following charges as specified in Annexure D:
- Premium Allocation Charge;
- Policy Administration Charge;
- Mortality Charge;
- Fund Management Charge; and
- Discontinuance Charge
- 12.2. We will deduct the above charges from the Unit Account in the manner specified in Annexure D.

## 13. Partial Withdrawals

- 13.1. You can make Partial Withdrawals under this Plan only after the completion of the first 5 (Five) Plan Years, subject to the Life Assured having attained the Age of 18 (Eighteen) years.
- 13.2. If you have chosen Regular Premium or Limited Premiums, then, you can make Partial Withdrawals only after payment of Regular Premiums or Limited Premiums, as the case maybe, for the first 5 (Five) Plan Years and after the completion of 5 (Five) Plan Years.
- 13.3. The minimum Partial Withdrawal amount shall be INR 5,000 (Five Thousand), whereas the maximum Partial Withdrawal amount shall not exceed 25% (Twenty Five) percent of the Fund Value.
- 13.4. If you have opted to pay Regular Premium or

- Limited Premium, then, the Fund Value after Partial Withdrawal should not be less than 110% (One Hundred Ten percent) of Annualized Premium.
- 13.5. If you have opted to pay Single Premium, then, the Fund Value after Partial Withdrawal should not be less than INR 45,000 (Forty Five Thousand).
- **13.6.** Under this Plan, no Partial Withdrawal charges will be deducted by us.

# 14. Switching

- **14.1.** You have the option of switching the Fund Value from one Fund to another Fund by giving a written notice to us as long as the Life Assured is of 18 (Eighteen) years of Age.
- 14.2. We will allow 2 (Two) switches in a calendar month i.e. 24 (Twenty Four) switches in a Plan Year subject to the condition that the minimum switch amount should be INR 5,000 (Five Thousand) and we will not levy any charges for switching of Funds. Any unused switch cannot be carried forward to the next calendar month.

# 15. Settlement Options

- 15.1. On the maturity of this Plan, the Life Assured has an option to withdraw an amount from the Fund Value in equal instalments at regular intervals for a maximum period of 5 (Five) years from the Maturity Date by sending a written notice to us atleast 3 (Three) months before the Maturity Date.
- **15.2.** During the Settlement Period, the Fund Value as on the Maturity Date will remain invested in the existing Funds till the end of the Settlement Period and the investment risk in such investments will be borne by the Life Assured.
- 15.3. For payment of maturity benefit installments, we will cancel the Units from the Unit Account from all the Funds. If more than one Fund has been invested in, then, the cancellation of the Units will be effected to the extent possible in the same proportion as the total value of the Units held in each Fund, unless specified otherwise by the Life Assured and accepted by us in writing.

- 15.4. During the Settlement Period, there will be no insurance coverage provided under this Plan. We will not allow any Partial Withdrawals or switching of Funds during the Settlement Period.
- **15.5.** During the Settlement Period, we will deduct only the applicable Fund Management Charges.
- 15.6. You have an option to request for complete withdrawal of the Fund Value at any time during the Settlement Period and no charges shall be levied by us. On receipt of such a request, we will pay the balance Fund Value as on the date of receipt of request to the Life Assured. On payment of the balance Fund Value, the Settlement Option will terminate.
- 15.7. If the Life Assured's death occurs during the Settlement Period, then, we will pay the balance Fund Value as on the date of receipt of the Life Assured's death to you. On payment of the balance Fund Value, the Settlement Option will terminate.

### 16. Funds

16.1. Under this Plan, you have the option to invest in the following 2 (Two) Funds, i.e. Equity1 Fund and Debt1 Fund. The details of the Funds offered under this Plan are provided in Annexure C.

### 16.2. Automatic Trigger Based Investment Option

Before the Plan Commencement Date, you have the option to choose the Automatic Trigger Based Investment Option provided you have agreed to invest in the Equity1 Fund. If you have opted for the Automatic Trigger Based Investment Option, then, we will review your Unit Account at the end of each Business Day to see if the simple absolute return on your investments in the Equity1 Fund (after deducting the Premium Allocation Charge, Policy Administration Charge, Mortality Charge and switching charge) is 10% (Ten percent) or more at the end of that Business Day.

If the simple absolute return is 10% (Ten percent) or more on such Business Day, then, an amount equal to the appreciation will be transferred to the Debt1 Fund (i.e. if the value of

the Units in the Equity1 Fund is 10% (Ten percent) or more of the net amount invested in Equity1 Fund, then, an amount equivalent to the appreciation will be transferred to the Debt1 Fund.)

You have an option to cancel the Automatic Trigger Based Investment Option for future transactions by submitting a written request to us during the Plan Term.

- 16.3. Under this Plan, you have the option of switching the entire Fund Value from the Equity 1 Fund to the Debt 1 Fund or vice versa, subject to receipt of a written request from you.
- 16.4. We have the right to introduce new funds to this Plan and offer the same to you, subject to receipt of prior approval of the Regulatory Authority.
- 16.5. We have the right to discontinue any of the existing Funds by giving you 3 (Three) months prior written notice, subject to the prior approval of the Regulatory Authority.

# 17. Risks associated with unit linked insurance plans

- **17.1.** This Plan has been issued by us on the basis of your acknowledgement and agreement that:
- IndiaFirst Life Insurance Company Limited is only the name of the insurance company and "IndiaFirst Money Balance Plan" is only the name of this unit linked fund based insurance plan and does not in any way indicate the quality of this Plan, its future prospects or returns
- Unit linked insurance products are different from the traditional insurance products and are subject to investment risks which are borne by you
- The premiums paid in the unit linked insurance policies are subject to investment risks associated with the capital markets and the NAVs of the Units may go up or down based on the performance of the Funds and factors influencing the capital market
- Investments in the Funds are subject to market risks and the investment risks in investment portfolio are borne by you

- The Funds or the names of the Funds as shown in this Plan do not in any manner indicate or guarantee the quality of the Funds, future prospects or returns. The past performance of any of our Funds is not indicative of the future performance of any of these Funds
- We do not guarantee the Fund Value or the NAV. Please note that depending on the market risk and the performance of the Funds to which the Units are referenced, the Fund Value or the NAV may fall, rise or remain unchanged. We have not given any assurance that the objectives of any of the Funds will be achieved
- The Funds do not offer a guaranteed or assured return except to the extent as guaranteed or assured by us under this Policy

### 18. Free Look Period

18.1. You can cancel this Plan if you disagree with any of the terms and conditions of this Plan within the first 15 (Fifteen) days of receipt of your Plan document. In case you have bought this plan through distance marketing mode. you may cancel the Plan within 30 (Thirty) days from the date of receipt of your Plan document. You will need to send us the original Plan document and a written request stating the reasons for cancellation, post which we will refund an amount equal to the non-allocated Premium plus charges levied on cancellation of Units plus Fund Value on the date of cancellation of the Plan less pro-rata Mortality Charges, stamp duty charges and expenses incurred on medical examination, if any and this Plan will terminate.

# Death Benefit Claim not Admitted under this Plan

19.1. You are not entitled to receive any benefits under this Plan, if the Life Assured, whether sane or insane, commits suicide within 12 (Twelve) months from the Plan Commencement Date or from the date of revival of this Plan. In such a case, we will pay the Fund Value as on the date of death of the Life Assured along with the charges deducted by us after the date of death of the Life Assured, if any and this Plan will terminate.

# 20. Nomination as per Section 39 of the Insurance Act

# 20.1. Appointing a Nominee to receive the Death Benefit

The death benefit will be payable to the person nominated as Nominee by you in the Proposal Form and specified in the Plan Schedule, in accordance with Section 39 of the Insurance Act.

#### 20.2. If the Nominee is a minor

If the Nominee is a minor, then, you may appoint an Appointee to receive and hold the death benefits for the benefit of the Nominee until the Nominee attains the Age of 18 (Eighteen) years.

### 20.3. Making/Changing a nomination

You can also nominate a person or change a nomination at any time during the Plan Term and while this Plan is in force, by submitting a written request to us. The nomination or change in nomination will become effective only after it is recorded by us in accordance with Section 39 of the Insurance Act.

#### 20.4. Our liability in a nomination

In accepting or recording a nomination or a change of nomination, we do not accept any responsibility or express any opinion as to its validity or legality.

# 21. Assignment

## 21.1. Assignment of the Plan

You may assign this Plan by making an endorsement on the Plan itself or through a separate instrument in accordance with Section 38 of the Insurance Act. In either case, you should submit a written request to us for registration of the assignment. Any assignment will automatically cancel any nomination made by you except in case of any assignment made by you in our favour in accordance with Section 39 of the Insurance Act.

Any assignment made by you under this Plan will become effective only after it is recorded by us.

Assignment is not permitted, if this Plan has been procured under the Married Women's Property Act, 1874.

### 21.2. Our Liability in an Assignment

In accepting or recording an assignment, we do not accept any responsibility or express any opinion as to its validity or legality.

# 22. Loan

**22.1.** Under this plan, you are not entitled to receive any loans.

## 23. Plan Ceases/ Ends/ Terminates

- 23.1. This Plan will cease immediately and automatically on the happening of the earliest of any of the following -
- on the date of payment of the death benefit under this Plan upon the death of the Life Assured; or
- on the date of intimation of rejection of claim by us; or
- if the due unpaid Regular Premiums or Limited Premiums, as the case maybe, have not been paid by you to us till the expiry of the Lock-inperiod or the Revival Period, whichever is later in accordance with Section 9; or
- on the date we receive a request for surrender or complete withdrawal of this Plan from you; or

- on the payment of Maturity benefit
- on the date of receipt of free look request in accordance with Section 18; or
- on the date, the Fund Value falls below 110% (One Hundred Ten percent) of Annualized Premium in accordance with Section 10.7
- on the date the Life Assured attains the Age of 75 (Seventy Five) years

# 24. Change of Address

24.1. You are required to inform us in writing, about any change in your/ Nominee's address. This will ensure that our correspondence reaches you/ the Nominee without any delay.

### 25. Disclosures

### 25.1. Misrepresentation/Fraudulent Disclosures

In issuing this Plan, we have relied on the truthfulness, accuracy, and completeness of information provided in the Proposal Form and the statements and declarations made by you which form a part of and are the basis of this Plan. If the information provided is found to be incorrect, then, this Plan will be cancelled and the Fund Value after deducting the Discontinuance Charges, if any, will be payable to you, subject to fraud or misrepresentation being established by us in accordance with Section 45 of the Insurance Act.

## 25.2. Provisions of Section 45 of the Insurance Act

This Plan is subject to the provisions of Section 45 of the Insurance Act, which states as follows:

"No policy of life insurance effected after the expiry of two years from the date on which it was effected be called in question by an insurer on the ground that a statement made in the proposal form for insurance or in any report of a medical officer, or referee, or friend of the insured, or in any other document leading to the issue of the policy, was inaccurate or false, unless the insurer shows that such statement was on a material matter or suppressed facts which it was material to disclose and that it was fraudulently made by the policyholder and that the policyholder knew at the time of

making it that the statement was false or that it suppressed facts which it was material to disclose.

Provided that nothing in this section shall prevent the insurer from calling for proof of age at any time if he is entitled to do so, and no policy shall be deemed to be called in question merely because the terms of the policy are adjusted on subsequent proof that the age of the life insured was incorrectly stated in the proposal."

# 25.3. Prohibition of Rebate: Section 41 of the Insurance Act

"(1) No person shall allow or offer to allow, either directly or indirectly, as an inducement to any person to take out or renew or continue an insurance in respect of any kind of risk relating to lives or property in India, any rebate of the whole or part of the commission payable or any rebate of the premium shown on the policy, nor shall any person taking out or renewing or continuing a policy accept any rebate, except such rebate as may be allowed in accordance with the published prospectus or tables of the insurer:

Provided that acceptance by an insurance agent of commission in connection with a policy of life insurance taken out by himself on his own life shall not be deemed to be acceptance of a rebate of premium within the meaning of this sub section if at the time of such acceptance the insurance agent satisfies the prescribed conditions establishing that he is a bona fide insurance agent employed by the insurer.

(2) Any person making default in complying with the provisions of this section shall be punishable with fine which may extend to five hundred rupees."

# 25.4. Making Untrue/Incorrect Statements or Withholding Information

If you or the Life Assured or the Nominee/Appointee/legal heir or anyone acting on your or their behalf advances any claim knowing the claim to be false, dishonest or fraudulent or submits untrue or incorrect statement or withhold any information, then, this Plan will be cancelled by us immediately and the Fund Value after deducting the

Discontinuance Charges, if any, will become payable to you, provided we have established such acts/ omissions in accordance with Section 45 of the Insurance Act.

### 25.5. False Disclosure about Age

The Life Assured's Age has been admitted on the basis of the declaration made by the Life Assured/ Proposer in the Proposal Form and/ or in any statement or declaration submitted alongwith the Proposal Form, on the basis of which this Plan has been issued by us. If the Life Assured's Age is found to be different from that declared, then, we may cancel this Plan immediately and the Fund Value after deducting the Discontinuance Charges, if any, will become payable to you, provided we have established such acts or omissions in accordance with Section 45 of the Insurance Act.

# 26. Right to Revise/ Delete/ Alter the Terms and Conditions of this Plan

26.1. We may revise, delete and/ or alter any of the terms and conditions of this Plan subject to receipt of the prior approval of the Regulatory Authority. We will intimate you by sending a prior written notice of 30 (Thirty) days, before revising, deleting and/or altering any of the terms and conditions of this Plan.

### 27. Loss of Plan Document

- 27.1. You should submit a written intimation about the loss of the Plan document and the reason for the loss. We will issue you a duplicate Plan document if we are satisfied that the original Plan document is lost or misplaced. The original Plan document immediately and automatically ceases to have any validity upon issue of the duplicate Plan document.
- **27.2.** You agree to indemnify us and hold us free and harmless from any costs, expenses, claims, awards or judgments arising out of or in relation to the original Plan document.

# 28. Electronic Transactions

- 28.1. You or the Life Assured will always adhere to and comply with all our terms and conditions in relation to electronic transactions and any electronic transaction effected by you or the Life Assured, as the case may be, will constitute a legally binding and valid transaction
- 28.2. Such electronic transactions will include any transactions effected by you through internet, teleservice operations, short messaging services, electronic data interchange, call centres, or by means of electronic automated machines or through other means of telecommunications, established by us or on our behalf for and in relation to this Plan or our other products and services.

## 29. Force Majeure

- 29.1. If due to any act of God or State, strike, lock out, legislation or restriction by any government or any other authority or any other circumstances which are beyond our control, which restricts performance of our obligations under this Plan, then, this Plan will be wholly or partially suspended during the continuance of such force majeure conditions.
- 29.2. Once the force majeure conditions ceases to exist, then, we will resume our obligations under this Plan for such period during which the force majeure conditions existed.

### 30. Issuance of Notices

30.1. We also have the discretion to issue either individual notices to you or to publish general notices on our website www.indiafirstlife.com in relation to this Plan and/ or for services in relation to the same

### 31. Taxes

31.1. We will deduct the applicable taxes in accordance with the applicable provisions of Indian tax laws. Any Premium and benefit payable under this Plan is subject to applicable taxes, levies, cess, etc, which shall always be paid by you. You are liable to pay all applicable

- taxes, levies, cess etc. as levied by the Government/ statutory authorities from time to time.
- **31.2.** You should consult your tax advisor for understanding the tax benefits and liabilities under this Plan. We do not accept any responsibility or express any opinion as to the validity or legality of tax benefits or liabilities as may be applicable to you.

# 32. Governing Law and Jurisdiction

32.1. All claims, disputes or differences arising under or in connection with this Plan will be governed by and construed in accordance with Indian laws and shall be subject to the jurisdiction of the Indian Courts.

- **33.5.** The complaint should be made in writing and the same should be duly signed by the complainant or by his legal heirs with full details of the complaint and the contact information of the complainant.
- **33.6.** As per provision 13(3) of the Redressal of Public Grievances Rules 1998, the complaint to the Ombudsman can be made by you or the complainant, within a period of 1 (One) year from the date of rejection of the grievance by us provided the same dispute is not already decided by or pending before a court of law.

### 2. Policy Administration Charge

- 2.1. We will levy a Policy Administration Charge at the beginning of each Plan month by cancellation of the Units for an equivalent amount.
- 2.2. If you have opted to pay the Premiums as Regular Premium or Limited Premium, then, we will levy a Policy Administration Charge of 1.8% (One and Eight Tenths percent) of the Annualized Premium for the first Plan Year, which will increase by 5% (Five percent), subject to a maximum of 5% (five percent) of annualized premium or INR 6000 (six Thousand) per annum whichever is lower.
- 2.3. If you have paid the Premiums as Single Premium, then, we will levy a Policy Administration Charge of 1.2% (One and Two Tenths percent) of the Single Premium for the

first 10 (Ten) Plan Years or Plan Term, whichever is earlier, subject to a maximum of INR 6000 (Six Thousand) per annum. We will not levy any Policy Administration Charge after the completion of the first 10 (Ten) Plan Years.

# 3. Mortality Charge

- 3.1. We will levy Mortality Charges for providing insurance coverage on the life of the Life Assured by cancellation of Units at the beginning of each Plan month. The Mortality Charge is guaranteed throughout the Plan Term.
- 3.2. We will levy the Mortality Charges on the sum at risk, i.e. the excess of the higher of Sum Assured or 105% of total Premiums paid over the Fund Value, subject to the sum at risk being non-negative, i.e. it should not be negative or zero, in accordance with the following table:

3.3. If the Life Assured is a female, then, an age setback of 3 (Three) years shall be applicable for the Life Assured who is of 21 (Twenty One) vears of Age as at last birthday and above for the purpose of calculation of Mortality Charges. If the Life Assured is a female who is between 18 (Eighteen) to 20 (Twenty) years of Age as at last birthday, then, the Mortality Charges for the Life Assured (male) who is of 18 (Eighteen) years of Age shall be applicable. No age discount will apply for the Life Assured (who is a female, if her Age is below 18 (Eighteen) years. The Mortality Charges may be different for substandard lives and the same shall be levied in accordance with our board approved underwriting policy.

### 4. Fund Management Charge

4.1. We will levy a Fund Management Charge of 1.35% (One and Thirty Five Hundredths percent) per annum on each of the Funds on each Valuation Date at the time of computation of NAV as a percentage of the Fund Value and shall be appropriated by adjusting the NAV. The Fund Management Charge shall not exceed 1.35% (One and Thirty Five Hundredths percent) per annum throughout the Plan Term.

# 5. Switching Charge

5.1. We will allow a maximum of 2 (Two) switches per calendar month i.e. 24 (Twenty Four) switches per Plan Year. Currently, we will not levy any switching charges during the Plan Term. However, we reserve the right to introduce charges for switching of Funds, subject to receipt of the prior approval of the Regulatory Authority, which shall not exceed INR 500 (Five Hundred) per switch.
