



Personal Belonging -Stand-alone Motor OD (Two Wheeler) Policy:Policy Wording UIN – IRDAN137RP0003V01201920/A0008V01202122

I. Operative Clause

SHRIRAM General Insurance Company Limited (We, Our or Us) will provide the insurance described in this Policy and any endorsements thereto for the Insured Period as defined in this Policy, to the Insured Persons detailed in the Policy Schedule and in reliance upon the statements contained in the Proposal and Declaration Form filled and signed by the Policyholder, which shall be the basis of this Policy and are deemed to be incorporated herein in return for the payment of the required premium when due and compliance with all applicable provisions of this Policy.

The insurance provided under this Policy is only with respect to such and so many of the benefits as are indicated by a specific amount set opposite in the Policy Schedule.

II. Definition (s)

1. **You, Your, Yourself:** The person or persons We insure as set out in the Schedule.
2. **We, Our, Us:**Shriram General Insurance Company Limited.
3. **Insured Vehicle:**The vehicle insured by Us under the Stand-alone Motor OD (Two Wheeler) Policy and as shown on the Schedule.
4. **Policy Period:** The period between and including the commencement date and expiry date as shown in the Stand-alone Motor OD (Two Wheeler) Policy
5. **Schedule:** The Schedule and any annexure or endorsement to it which sets out your personal details and the insurance cover in force.

Scope of Cover

We will pay for the loss or damage to Your's personal belongings as mentioned in policy schedule caused by perils mentioned under section 1 of the policy while You are using the vehicle at the time of loss or damage to the vehicle.

Personal belongings for the purpose of this section means items such as clothes and other articles of personal nature.



Condition(s)

1. The claim for accidental damages is payable under the Policy or in case claims due to burglary, house-breaking or theft a police report must be filed.
2. The Coverage will be applicable during the policy period and can be used maximum up to 2 times in year.
3. The insured will bear 10% of limit of indemnity selected subject to minimum of ₹100 in each and every claim.
4. In case of transfer of ownership of the Insured Vehicle, the cover shall expire.
5. Minimum sum insured to opt this cover is ₹ 500
6. All other terms and conditions as per the base policy.

Exclusion(s)

1. Loss of excludes money, securities, cheques, bank drafts, credit or debit cards, jewellery, lens, glasses, travel tickets, watches, valuables, manuscripts, paintings, electronic equipment such as cellular phones, data, and photographic, audio, video and telecommunications equipment and items of similar nature.
2. Any goods or samples carried in connection with any trade or business is not covered.
3. Any claims intimated to us after the 15 days for such loss.
